Interested in running for a position on the Management Committee?


The Nomination Committee is in the process of contacting prospective candidates. If you are interested, or know someone who might like to be considered, please contact Judy, Janet, or Patty.

THE K1's are ready to pick up at the office. They will be printed when you request it.

Two things of interest to you, the Partnership:

One, we have sent all the year-end information to the accountant and their office has completed the K1's. They are available to pick up at the office.

Two, by this letter, we are advising you that we paid property taxes last year (2023) for the partnership and you as partners can include your portion as a deduction. To calculate your portion, multiply the number stated on your **2023** Rent Statement for **Property Tax** times 12 months. This will give you the amount which you can use as a deduction on your Schedule A tax form if you itemize deductions. *Example: If the Property Tax line item on your rent statement is \$21.67, multiply by 12 months, your deduction is \$260.04.* This is in addition to the property tax you pay direct to the county for your Manufactured Home. This number will not be included on the K1 statement, so you will want to keep this letter with your tax documents for your tax preparer.
